Foreign Exchange Commission is charged whenever there is a conversion relating to payments (outward / inward) or to other services between two different currencies (including Euro).

For all currencies: 0,40%, min €5 / max €400

- 3. The Bank accepts instructions for outward payments through SEPA in Euro up to €500.000.
- 4. For the cases where VAT is applicable, it shall be applied over and above the official Bank's charge.
- 5. Administration Fees (Currency Exchange Services) are charged when the transaction is performed in a country where the currency is different from Euro.
- 6. Additional information for specialised banking activities may be provided, upon request, by any Branch/Unit of cdbbank.
