3. The Bank accepts instructions for outward payments through SEPA in Euro up to €500.000.
4. For the cases where VAT is applicable, it shall be applied over and above the official Bank's charge.
5. Administration Fee (Currency Exchange Services) are charged when the transaction is performed in a country where the currency is different from Euro.
6. It is noted that the abovementioned accounts will continue to bear interest rate in accordance to the Bank's pricing policy from time to time, depending on the account type.
7. Additional information for specialised banking activities may be provided, upon request, by any Branch/Unit of cddb bank.
