Foreign Exchange Commission is charged whenever there is a conversion relating to payments (outward / inward) or to other services between two different currencies (including Euro).
For all currencies: 0,40%, min €5 / max €400
3. The Bank accepts instructions for outward payments through SEPA in Euro up to €500.000.
4. For the cases where VAT is applicable, it shall be applied over and above the official Bank's charge.
5. Administration Fees (Currency Exchange Services) are charged when the transaction is performed in a country where the currency is different from Euro.
