(c) **Hard Token Device** means the battery-operated electronic device provided by the Bank to the Authorised User upon the relevant application to acquire one, which generates One Time Passwords (OTP's) to facilitate first login and/or confirm instructions. The Hard Token Device can be acquired by paying the relevant charge, as this is stated on the Bank's Commissions and Charges Table available on its website [www.cdb.com.cy](http://www.cdb.com.cy).
