ISO 20022 - XML - pain.001.001.03



Scope

This document aims to describe the identifiers used for the presentation of payments in an xml file. A set of mandatory and optional identifiers can consist a single payment. The XML file is built based on the ISO20022 standards and supports the pain001.001.03 file format. The XML file can contain multiple types of payment and it can be used for upload on cdbbank's E-banking system using the "Bulk Payments" service. All files uploaded will be validated against the defined identifiers for the payments through cdbbank and with the basic rules of payments.
